Fees: This race is part of Cal's All Comers' Track & Field meet that day. **Pay at the entrance (approximately \$10).**

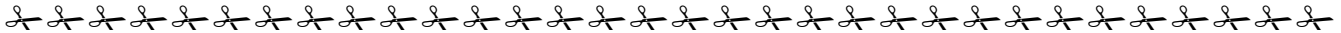
